a. Lesbian

b. Gay

All humans are widely wide-spread, interdependent, indivisible and interconnected. According to (Samanik, 2018) Sexual orientation and gender identity are included with human dignity and humanity so that should no longer be the basis for discrimination and violence". (Kardiansyah, 2016) based totally in this human rights, many parties emerged who inquisitive about traumatic those rights despite the fact that later the needs are contrary to their nature as humans (Damayanti et al., 2021). One of them is the same-sex marriage legality campaign always uses the pretext of rights human rights as an effort to formalize their relationship (Aji & Dewi, 2017). As (Kardiansyah, 2019) Stated that The efforts of certain parties who want the legality of same-sex marriages do not mean that they also walk smoothly without any refusal even though using the language of human rights (HAM) so that obtain their rights due to the opposition of several parties who do not agree.

LGBT in Indonesia continues to be a taboo situation, specially for organizations who his thoughts are based on religion (Pranoto, 2021). typically blasphemous conduct and sexual orientation this LGBT organization (Oktavia & Suprayogi, 2021). MUI has even issued a fatwa rejecting the exercise of family members equal-intercourse marriage and marriage (Mandasari, 2017). There also are a few folks that are impartial, accept the LGBT state of affairs however do not assist LGBT sports openly (Mandasari & Oktaviani, 2018). 





These varied perspectives can be explained in a qualitative study of students who stated that LGBT was something strange because it had never appeared before in their lives, because no family, friends, or environment had ever mentioned it, until finally he graduated and heard about it. on the issue of same-sex marriage in their home country. He described his fairly negative perception as "how did this strange sexual orientation come about?" and "they are queer people with mental disorders" which he then sums up in contradictory attitudes toward homosexuals. The above also appears in the respondent's idea of a strange view of LGBT when they see the news in the media.

The research respondents who stated that they were pleased with the homosexual point of view were human rights. This arose after the student witnessed a debate about the legality of same-sex marriage in which there were differences of opinion between religious groups and human rights activist groups.

The idea that came from the respondent said that one of the reasons why a person becomes an LGBT person is the family factor, in which there is a wrong form of upbringing since childhood, namely treating children not according to their gender, as well as the broken home factor, according to Adriaens in 2006, the need for Social relationships in families that are not intact or not fulfilled, tend to shape children's behavior that leads to same-sex relationships (homosexuality), this also arises in the minds of respondents who reveal that the first community of an individual is his nuclear family, so if there are things that are not fulfilled, it will affect the formation of an individual's identity, according to Smith's (2004) research about someone who lacks parental affection as a child, is known to have same-sex attraction. In addition, those who think because of Lack of knowledge about religion, Lack of knowledge about education, Wrong association, and Environmental factors.

CONCLUSION

Based on the results and discussions that I made, the students' perceptions of the LGBT phenomenon are as follows: Individuals who have an LGBT identity are not able to understand their own religion, so they have an interest in the same sex. Everyone has a different perspective in viewing LGBT behavior, with a tendency to favor or contradict it.
