Discourse practice (mesostructural) is a dimension related to the process of producing and consuming texts. Sociocultural practice (macrostructural) is a dimension related to context outside the text. The three dimensions are then analyzed using three different stages of analysis, namely the description used to analyze the text, including cohesion and coherence, grammar, and diction, interpretation is used to analyze the interpretation of the text, including the production, distribution, and consumption of the text, and the explanation used to analyze socio-cultural practices that cover situational, and social levels.

In this mini research the method used was descriptive method. in this method, data were generated descriptively; the point was that the data obtained was not seen from right and wrong, presented as systematically, factually, and accurately about the data, nature, and its relation to phenomena. The method used in research was listening, which was listening to the news delivered and also listening to the headline, examining the purpose of the title along with its objectives and objectives. The title given in this news is that Mulan Jameela Pioneered Online Business. In the headline it appears that the phrase given to Mulan Jemeela with the disclosure of the syntactic function of the predicate has moved. The phrase has moved in that sentence implicitly preaching the positive side that Mulan Jameela who has now left the bad things to the good.

In addition, the information Now Starting a Business Online represents the profession or career of a Mulan Jameela. In the headline there was no mention of what kind of business Mulan Jameela was running. So the words "business" and "online" are choices to focus on the news. In this case, Liputan6.com also reported the existence of a spiritual event, namely "hijrah" experienced by a Mulan Jameela. As a result or impact of the events of the hijrah is Mulan Jameela who originally worked as a singer who always dressed in open clothes now plunged into a businessman. Based on various information tools used by these people to get any news, and one of them is the coverage of Mulan Jameela. Through the vocabulary used in the form of choice of formal and non-formal vocabulary, expressions and grammar, syntactic functions and forms of devotion. In the words of Hijrah, Mulan Jameela was marked by the presence of the hijrah information function. The word hijrah has the meaning of change for the better.

In the other news delivered, that used to be the section, Mulan Jameela is now more comfortable wearing Syar'i clothes, and this is included in the sentence of conflict because it compares the past and present life of Mulan Jameela. It used to refer to Mulan Jameela's negative past life, as a celebrity with a sexy image. Function information First the section was the topicalisation of the discourse which was then opposed to the clause More Comfortable in Syar'i Clothing. The presence of a More Comfortable clause Using Paju Syar'i indicates that detik.com wants to highlight the positive side of a Mulan Jameela. The choice of comfortable vocabulary shows Mulan Jameela's consistency in using syar'i clothing. In addition, the use of the word shar'i which is a word that comes from Arabic namely shari'ah is interpreted as long and loose clothing for Muslim women. Therefore, the news stated the positive side that a Mulan Jameela not only covered the genitals (hijab), but now dressed in good Muslim clothing and in accordance with Islamic law. The form of reporting in that sentence is the shape of the situation, namely detik.com wants to compare the past situation of Mulan Jameela who is often dressed sexy and the present condition of Mulan Jameela who has been using syar'i clothing.

In this news also shows the negative side of another Mulan Jameela that is by saying that the singing job is reduced, this phrase provides information about the profession of a Mulan Jameela who as a singer but there is no call to sing. In this news also given the cause and effect that is, because there is currently no call to sing Mulan Jameela doing business online. In the online business news that is run by Mulan Jameela is selling Muslim clothes, and in my opinion the business of selling Muslim clothes has something to do with the migration of a Mulan Jameela who previously did not wear the hijab but now has used it.

The next news is discusses about Jameela's Mulaan is about "Beautiful Mulan Jameela's Photographs in the Hijab and Already Leaving a Sexy Image." In the headline it appears that tribunnews.com highlights the positive side of a Mulan Jameela shown by the phrase "Leave a Sexy Image." However, in my opinion the phrase is ambiguous. And the good news is that tribunnews.com leaves the reader in two interpretations, namely stating the negative side of Mulan Jameela that in the past Mulan Jameela was a celebrity who often appeared sexy and positive, namely Mulan Jameela, who has now closed genitalia. In this report there is also a sentence which forms a situation. Here, Tribunnews.com uses the word hijab to proclaim the state of Mulan Jameela who went through the hijrah process and finally decided to veil. Vocabulary selection, such as beautiful and hijab dressing strengthens or adds to the positive side of Mulan Jameela.
